
**DSCSA Purpose:** To ensure that prescription drugs can be traced through the supply chain, from manufacturers to dispensers.

#### **Locating GLNs**

GLNs can be found in Customer Center under DSCSA Report, on McKesson Specialty invoices and packing slips, or by contacting your Account Manager

#### **Obtaining Serialized Data**

Access serialized transaction data via Customer Center or Lynx by navigating to the respective DSCSA reports, selecting GLNs and exporting the data

#### Purchasing Drugs Through Non-McKesson Channels

Ensure all wholesalers or distributors have your GLNs to avoid service disruptions when purchasing drugs through non-McKesson channels



#### Tracking Transfers

Drug transfers within a common entity without a change of ownership are exempt from trace and trace requirements

#### **Enforcement Exemptions by the FDA**

The FDA granted enforcement exemptions to entities, allowing more time to achieve compliance. Enforcement will begin **5/27/25** for manufacturers, **8/27/25** for distributors, **11/27/25** for larger dispensers and **11/27/26** for small dispensers

### **DSCSA – General Overview**

### **Goal: Secure drug supply chain**

- Protects patients from receiving harmful drugs, including counterfeit, stolen, or contaminated drugs
- The DSCSA aims to create a fully serialized pharmaceutical supply chain, allowing every drug and ingredient to be traced from the manufacturer to its final destination
- Facilitates a more efficient supply chain by enabling a seamless electronic flow of data between supply chain partners

### GLN (Global Location Number) is a globally unique identifier

- $\circ$  Issued by <u>GS1</u>
- Sold-To GLNs identify "who purchased"
- $\circ~\mbox{Ship-To}~\mbox{GLNs}$  identify "where it was shipped"
- $\,\circ\,$  GLNs  $\,$  can be viewed in the following ways:
  - Customer Center DSCSA Report; invoices; packing slips
  - Lynx DSCSA Traceability Report
  - Account Representatives and CSMs can provide GLN lists as needed

### **DSCSA – Risks and Challenges**

### **Purchasing from non-McKesson sources**

- Ensure non-McKesson suppliers are trusted trading partners in compliance with all DSCSA requirements *and* have your GLNs on file to prevent shipment disruption
- If not utilizing a third-party data aggregator, tracing data from non-McKesson suppliers will need to be independently accessed

### **Transferring product to other practices**

- There are no restrictions to intra-practice transfers
- Transfers to other entities such as a local hospital are permissible when patient-specific
  - Recommend developing a log to track external transfers

### **Returns process**

- $_{\odot}\,$  Serialization confirmation will be required for saleable returns
- o Required data will be searchable via Customer Center Portal or Lynx

## **DSCSA – Key Dates**

- The DSCSA Stabilization Period will continue; and compliance will become enforceable on a phased approach throughout the next 24 months
- McKesson Specialty, Pharma, and MPB have already implemented order holds for accounts with missing GLNs
- McKesson Medical Surgical (MMS) will implement order holds starting November 4, 2024
- McKesson is developing an enterprise GLN reconciliation process across all business units

### Small Business Dispenser <u>Exemptions</u> (through November 27, 2026)


- Dispensers with 25 or fewer full-time licensed pharmacists or qualified pharmacy technicians
- Exemption is automatic
- Must have GLNs on file with suppliers, have SOPs for reporting suspect product, and comply with McKesson Returns Process
- May be unnecessary because all reporting requirements are met with McKesson portals



### **DSCSA – Practice Action Items**

#### • Have policies for <u>suspect or illegitimate product investigations</u>

- <u>Sample P&P</u>
- Ensure staff are familiar with quarantine and reporting obligations
- Ensure staff know how and have access to generate traceability reports
- Review State Board regulation and requirements from applicable accreditation bodies
- Document drug transfers between outside entities as patient-specific whenever possible, and record in a log
- Provide your GLNs to all non-McKesson suppliers to prevent shipment disruptions
